Don't Miss the One-on-One CEO Sessions at the RFA Conference!

Get the most out of the RFA Conference by taking part in the One-on-One CEO Sessions! They are a one-of-a-kind event where suppliers get the chance to meet face-to-face with the CEOs and key decision makers of RFA manufacturing members for 10-minute sessions.

Based on feedback from past Conferences, these sessions are one of the top benefits of RFA membership for Associates, as they provide the opportunity to learn the individual needs of each manufacturer.

This year, the One-on-One CEO Sessions are scheduled for 9:30 - 11:40 a.m. on Tuesday, February 28, the second-to-last day of the Conference. To participate in the sessions, you must meet the following criteria:

1) be a member of RFA; 2) be registered for the 2023 Conference.

The unique One-on-One CEO Sessions allow you to meet face-to face with key RFA Manufacturers for 10-minute sessions.

The CEO Session sign-ups will take place at the Associates meeting at 8:00 am on Tuesday morning. This is the only time you will be able to sign up, so make sure you attend! Only one representative from each Associate Member Company may participate in the CEO session signups.

The actual CEO Sessions will begin promptly at 9:30 a.m. on Tuesday. Please arrive on time and prepared for your scheduled appointments. Representatives from the manufacturing companies will be seated at individual tables throughout the room. A bell will signal the start of each 10-minute session. Go to the company's table that you are scheduled to meet with at the appointed time and begin your meeting. After 10 minutes, the bell will ring again and it will be time to move on.

Prior to the Conference, the RFA staff will email out the list of Manufacturing member companies participating, along with a profile of each company and instructions for the sign-up process. We ask that you review these profiles beforehand so that you can make appropriate selections for your meetings.

New Associate Board Representative to be Elected at 2023 Conference

This year, the Associates will elect one new Associate member to serve a 3-year term on the RFA Board of Directors. The available position is open this year and for an Associate member from any category.

To qualify for this Board position, your company must have been a member of the RFA for at least three years and exhibited at the 2020 RFA Conference in Orlando, FL.

The RFA Associate member companies that qualify for this 3-year term in office are listed to the right. Any representative from the company may be nominated and serve on the Board. There is a limit of two consecutive terms.

However, only one representative from each company may be nominated. (Note: Representatives must be present at the Associates' meeting at the 2023 Conference to be elected.)

Nominations for this position will be accepted at the Associates' Meeting in Kiawah Island, SC, on Tuesday, Feb. 28, 2023, at 8:00 a.m. Associate election ballots will be due to the RFA staff by noon on Tuesday, Feb. 28, 2023.

Each Associate member in good standing is permitted one vote PER COMPANY in the election. The elected representative will serve as your voice and will be a voting member on the Board of Directors.
