Available to any individual, firm or corporation engaged in the manufacture and sale of prepared, refrigerated food products. These foods are defined as edible preparations that are commercially prepared, safely packaged, requiring refrigeration, and ready-to-eat/heat/cool (i.e. wet salads, entrees, salsa, pizza, sauces, dips, ethnic foods, soups, sandwiches, chilis, prepared eggs, dressings, desserts, etc.).
